I refer to your official information request dated 1 December 2025 for how many requests for access to Stacks Conservation Area the Commission has received, and the outcomes of those requests.

The information you have requested is as follows.

Our case management system contains records for four cases relating to access to the Stacks Conservation Area.

- A case from 2025 in which an enquirer asked about carrying a bow and arrow on an easement near
 Spotts Creek to gain access to the Stacks Conservation Area. We closed the case earlier this year,
 responding to the enquirer that a bow is not a firearm and therefore can be carried on the easement.
 The Department of Conservation has confirmed that hunters can use the marginal strip to access the
 Stacks Conservation Area, provided that weapons are not loaded, not used from the marginal strip, and
 a hunting permit has been issued.
- Another case from 2025 in which an enquirer asked about access to the Stacks Conservation Area in Cardrona Valley. We closed the case after providing the enquirer with advice and directing them to talk to the Department of Conservation.
- A case from 2023 involved a hunter inquiring about access to the Stacks Conservation Area above Cardrona road. Our regional field advisor closed the case in 2024, noting that he would continue to raise the issue with the Department of Conservation at future meetings.
- A case related to an enquiry in 2020 about a fence blocking access to Waterfall Creek. Our regional field advisor closed the case in 2021, noting that the Department of Conservation has ensured fencing would be removed and that it had clarified it does not maintain the Public Access Easement in the area.
